RESIDENTIAL SERVICES DURING THE 2018 FISCAL YEAR, 296 YOUTH WERE SERVED IN OUR SPECIALIZED RESIDENTIAL TREATMENT PROGRAMS. OUR TREATMENT SERVICES ADDRESSED BEHAVIORAL ISSUES SUCH AS JUVENILE DELINQUENCY, SEX OFFENSES, SUBSTANCE ABUSE AND MENTAL HEALTH ISSUES. THIS YEAR, WE EXPANDED OUR ABUSE AND NEGLECT SERVICES FOR GIRLS AND BEGAN WORKING WITH A CHARTER SCHOOL ON OUR RESIDENTIAL CAMPUS ALLOWING STUDENTS TO EARN A HIGH SCHOOL DIPLOMA WHILE IN OUR CARE. THE AVERAGE LENGTH OF STAY FOR YOUTH RECEIVING RESIDENTIAL SERVICES IS 9.7 MONTHS. 74% WERE RELEASED TO FAMILY OR ANOTHER COMMUNITY SETTING.

OUR PROGRAMS INCLUDED A DELINQUENCY DIVERSION PROGRAM AND AN INTENSIVE IN-HOME TREATMENT PROGRAM. THE INTENSIVE IN-HOME PROGRAM UTILIZED PLAY THERAPY, INDIVIDUAL AND FAMILY THERAPY COVERING TOPICS SUCH AS PSYCHOEDUCATION, PARENTING, SELF-ESTEEM, PREVENTION OF SELF-HARM, ANGER MANAGEMENT, RELAXATION, COMMUNICATION, FAMILY DYNAMICS AND APPROPRIATE BEHAVIOR. THE DIVERSION PROGRAM INCLUDES TUTORING AND MENTORING, GROUP AND INDIVIDUAL THERAPY COVERING TOPICS SUCH AS SCHOOL BEHAVIOR, MAKING GOOD CHOICES, SUBSTANCE ABUSE, HEALTH, CONSENT, FRIENDSHIPS, JOB SEEKING, CAREER AND FUTURE GOALS, FAMILY RELATIONSHIPS, COMMUNITY SERVICE.

PROFESSIONAL TRAINING AND COACHING DURING THE 2018 FISCAL YEAR, 5,998 PROFESSIONALS RECEIVED TRAINING ON THE TOPICS OF HUMAN TRAUMA, POSITIVE YOUTH DEVELOPMENT, BUILDING RESILIENCE, MINDFULNESS, SELF-CARE, SUICIDE PREVENTION, RACIAL HEALING, CHILDHOOD SEXUAL BEHAVIOR AND ADHD THROUGH E-COURSES AND TRAINING EVENTS ACROSS THE UNITED STATES AND CANADA. 282 TRAINING EVENTS WERE OFFERED AND ATTENDED.
